# **Executive Committee Code of Conduct**

The Executive Committee is according to Article 8.1 of the constitution of the XR4REHAB network, the managing and administrative body of the association. The powers and duties of the Executive Committee are set out in Article 9 of the constitution.

The main responsibilities of a member of the Executive Committee are to provide leadership and direction to XR4REHAB and to govern the affairs of XR4REHAB on behalf of its members. In representing the members of XR4REHAB and acting as their "trustee" an Executive Committee member has four basic duties:

A duty of diligence: to act with responsibility and integrity and in good faith.

A duty of loyalty: to act in the best interests of the association and its membership disregarding any personal interests.

The executive committee operates as a single entity and members must support the decisions of the committee, regardless of the fact that they might not agree with the decision or may have voted against the decision. An Executive Committee member should not speak negatively about XR4REHAB in public.

A duty of confidentiality: members have an obligation to keep committee business private, and should not discuss XR4REHAB matters to which confidentiality attaches outside the committee. A duty of compliance: to act within the scope of the governing constitution and policies of XR4REHAB and any rules, regulations and protocols that apply to XR4REHAB. Committee members must also ensure that any staff within their authority and any other bodies or working groups etc within XR4REHAB do so as well.

Before joining the Executive Committee, prospective members should consider their reasons for becoming a member. Aspiring members must ensure that they are able to devote sufficient time, interest and commitment to the role in order to be able to assure the membership that they can make a valid contribution to XR4REHAB and should also ensure that they familiarise themselves with the mission, objects and activities etc of XR4REHAB.

Each member of the XR4REHAB Executive Committee acts as a liaison point for their particular geographic region.

## **Member Code of Conduct**

Both natural persons and legal entities may be Members of the association irrespective of their nationality. Legal entities need to appoint one person representing the legal entity in case of voting at the time of General Assembly Meetings.

Membership of the association shall be personal and, as such, not susceptible of assignment or transfer. XR4REHAB favors quality over quantity. Members are expected to have an active role within the association, either within one of the working groups or in another meaningful way.

Members must support the decisions of the committee, even if they might not agree with the decision and might have voted against the decision.
